# Notice of The 2023 Annual Meeting of the Members of the Horizon Towers Condominium Association and Election of Board of Directors

The purpose of the meeting is to elect members to the Board of Directors, to transact the business of the Horizon Towers Condominium Association (HTCA), and to act upon such other matters as may be brought before the meeting by HTCA Members.

In accordance with the HTCA Bylaws: The affairs of the association shall be governed and managed by a Board of Directors composed of five (5) persons. Each of whom must have an ownership interest in a condominium at Horizon Towers.

Directors shall be elected by secret written ballot of the members at the Annual Meeting of the membership.

To be eligible as a candidate for the office of Director, a Member shall notify the Secretary of his or her intention to be a candidate on a Declaration of Candidacy form, signed by the Member, who shall include a certification that he or she will reside in a Condominium at Horizon Towers during such term of office. Notwithstanding anything to the contrary in this section, one (1) Director seat may be filled at each election by a Director candidate who does not reside in a Condominium at Horizon Towers, which seat the board shall designate prior to the casting of any votes.

Members intending to run for the HTCA Board must submit their completed Declaration of Candidacy form to the HTCA office. **Declarations must be received no <u>later than Thursday</u>**, <u>October 26, 2023.</u> The declaration form is enclosed. Additional forms are available in the HTCA Office.

If you are unable to attend the Annual Meeting to vote in person, you are encouraged to arrange for a representative to vote for you by proxy. After you have a representative who has agreed to vote your proxy please complete and return the attached proxy form to the HTCA Office. If you mail the proxy, we must receive it at least 24 hours prior to the scheduled meeting. Use only the

enclosed proxy form or contact the HTCA Office for an official replacement if needed. Do not send your proxy directly to the person you are authorizing to vote your proxy as this is a controlled document that must be received by the Office and validated before it can be used.

Returning your proxy will help the association achieve quorum to make certain we can have a valid election. Thank you in advance for signing and returning your proxy if you are unable to attend the meeting.
